2. Greetings by Chairman (Dr. Sung-Won Lee, President, ASF)

First of all, I sincerely welcome all of you to the 8th ASF Congress in Miami, U.S.A., coinciding with the 44th FIS General Congress this time. This is the first time for ASF congress to be held in North American Continent and specifically in U.S.A. It is regrettable to see a number of countries are absent this time at the ASF Congress in Miami including some countries due to entry visa problem.

However, we have a new provisional member of Hong Kong, the Ski Association of Hong Kong, China headed by the chairman Edmond Kwok Yin YUE and his associate Henry Hin Kwan PANG, is present here today to witness ratification of their membership during this congress. I sincerely welcome the participation of Hong Kong Ski Association to ASF at this congress. Their participation to FIS as an associate member will be also ratified during the FIS Congress. I welcome attendance of Mr. Jamil LAHOUD, vice president of the Lebanese Ski Federation as a director of ASF who was elected to the post at the last interim election for a director of ASF. I welcome Mr. Julfiqar Hussain KHAN, new secretary general of the Ski Federation of Pakistan, first time to the ASF Congress. My welcome greeting especially to Mr. Weimin PAN from China to the ASF Congress this time, who had been absent last few times, and also greeting to new vice president of Chinese Ski Association, Mr. Younian TIAN.

ASF's big event 13th Asian Alpine Ski Championships (Junior) 2004 was held in Dizin ski resort of Iran successfully. I extend my thanks to I. R. Iran Ski Federation for their effort in conducting the championships, especially as a junior championships under an official supervision of FIS TD. It was a meaningful development for ASF to conduct a junior championships first time.

I thank you, once again, for your attendance to the congress and wish each National Ski Association for the continued success and prosperity, expecting to see your attentive support, initiative and good cooperation for the future development of ASF. • Special Guest Speech (Mr. Gian-Franco Kasper, President, FIS):

4-3 Report on the Activities of the Finance and Marketing Committee for 2000-2002

Mr. Farshid Alizadeh, chairman of the Finance & Marketing Committee, did not submit any report about tangible results of committee's activities.

President expressed a grave concern about total non-activities of the committee for last four years since the establishment of the committee with a big expectation. He clearly sees the difficulty in continuity of the committee existence. Mandate was given to president to discuss and finalize the issue of abolishment of the committee with other ASF vice presidents and Mr. Atsumi Seo, only member of the Finance Committee. President expressed it is not good to have a committee of name only without any contents.

4-4 Report on the 13th Asian Junior Alpine Ski Championships at Dizin Ski Resort, Iran in March 2004 (Reported by President)

President reported about the results of the 13^{th} Asian Alpine Championships (Junior) based on their report submitted, because of the absence of Iranian delegates at this congress. Originally, the 13^{th} Asian Alpine Championships (Junior) had been planned for March 2003. However, it was cancelled due to uneasy situation around Iraq at that time. Upon discussions and agreement with the I. R. Iran Ski Federation, the championships was postponed to 2004. The championships was, therefore, held successfully during March 9^{th} – 13^{th} , 2004 at Dizin Ski Resort.

The FIS Aid and promotion Program supported round trip airfares for 3 racers and 1 coach. President was not able to participate the championships due to his post-operation care of the right shoulder. Mr. Shoji Maruyama was present on behalf of the president. 12 countries and 43 racers participated the championships.

President stressed the point that this time the championships was for "Juniors". This is the first "Junior" championships after our official decision of the ASF to alternate children and junior for annual Asian Alpine Championships. Now, we can witness that a Child II racer grows up to a Junior I and winning silver medals in both GS and S of Junior I this year. It is the case of Saveh Shemshaki, an Iranian boy racer, who grew up to Junior I this year and continue to race for ASF's Asian Alpine Championships winning silver medals.

This time, Kuwait participated first time with one racer. Some racers did not have FIS code numbers, which resulted some difficulties. All junior competitors are urged to obtain at least FIS Code numbers for ASF's junior competitions in future. President assured of that this championships contributed greatly to enhance the friendship and the solidarity between each member countries.

4-5 Difficulty of Winter Games Federation of India in Iran

According to the speech opened by Mr. R. K. Gupta, he regretted with an expression of apology that he had informed Secretary General of FIS about their trouble in Teheran at the time of the championships before informing ASF Secretariat about the difficulties.

President stressed that for such a matter there is nothing FIS can do or can help. It must be solved within ASF. Any compensation matter for the troubled air tickets of Indian team will be studied in details at ASF secretariat office with all the evidence materials. Due compensation would be made as soon as possible when it is proven appropriate. It was also stressed that all the participation teams have to be well taken care of to the last minute of departure from the airport back to home. President expects a better communication in future between country and secretariat office on such an occasion to solve any internal matter of ASF within the frame of ASF.

5. Discussions

5-1 Application of ASF Membership by the Ski Association of Hong Kong, China

President explained the background of the application by Hong Kong Ski Association and asked the ratification by the congress as an Affiliate Membership of ASF for the Hong Kong Ski Association.

According to the statute of ASF, a full membership is conditioned upon that a full member must conduct competitions at the national level with participation from its member associations (Article 3.1.3). The provisional membership was ratified as an affiliate member unanimously, and the Hong Kong Ski Association became officially as an Affiliate Member of ASF.

The Hong Kong Ski Association is also applying the membership to FIS and the association will become officially an Associate Member of FIS during this congress. President sincerely welcomes the newly established Hong Kong Ski Association, under the approval of Hong Kong Olympic Committee, to ASF and FIS and looks forward to having good cooperations in future.

President expects the Hong Kong Ski Association to have a good control and administration over many scattered Hong Kong resident skiers all over the world abroad. Some notable racers abroad should registered at FIS as Hong Kong racers and could compete as Hong Kong racers abroad where they reside. President also expects good cooperation between Ski Association of Hong Kong, China Ltd. and Chinese Ski Association of Beijing in future for development of ski in China and Hong Kong.

5-2 Agenda Proposals by Member Countries

5-2-1 Pakistan

Mr. Zulfiqar Hussain Khan, secretary general of Ski Federation of Pakistan, requested the coaches training and ski equipments supply through FIS Aid and Promotion Program.

5-2-2 Japan

Mr. Shoji Maruyama, vice president of ASF proposed Alpine Coaches Seminar, to be conducted, coinciding with the Asian Alpine Ski Championships (Junior or Children).

President summarized the proposals by member countries, and expressed his opinion and feeling towards the proposals. For coaches training, president also supports the idea. However, the most difficult part on such a project for ASF is coast of airfares for coaches to assemble to the place of seminar or training across the Asia continent. Therefore, we should formulate coaches seminar whenever coaches assemble annually for Asian Alpine Ski Championships (Junior or Children). A matter of fact, we once conducted such a coaches seminar at Yongpyong, Korea when we had the 4th Asian Winter Games (January 30th – February 6th, 1999) and all the alpine coaches assembled at Yongpyong. ASF only requested to FIS for a seminar instructor, his travel coast and remuneration. The seminar was very successful and all the participated ASF coaches were very impressed. It was very beneficial to all the coaches joined the seminar.

As Mr. Shoji Maruyama proposed, we will conduct alpine coaches seminar and training when we have Asian Alpine Ski Championships annually, coinciding with the championships.

Regarding Pakistan's request for any financial support from FIS Aid and Promotion Program for their purchase of ski equipments, president expressed some difficulties. FIS Aid and Promotion Program is already distributing a fixed amount of money to each affiliated ski developing nations each year for ski equipments. Therefore, the FIS Aid and Promotion Program can not meet individual country's request for such a project as ski equipment purchase.

However, each country should study into a possibility of applying for FIS Solidarity Fund. One can formulate a good project proposal independently within the country and request for partial or full financial support from FIS Solidarity Fund depending on the size of the project. President feels that the most appropriate size of request amount is around SF15,000 ~ 18,000 per project. A coaches training program or higher-level racers training program within a country may be appropriate for such a project proposal. President stated that if any country comes up with a good project proposal, he would try to help during the course of application to FIS Finance Commission. Therefore, president should be consulted in advance before filing an application.

5-3 Site for the 14th Asian Alpine Ski Championships 2005 (Children)

As already been agreed upon at the 7th ASF Congress in Portoroz, Slovenija, China is confirmed to hold the 14th Asian Alpine Championships (Children) in 2005 in china. Final decision for the site of the championships between Peidaho and vicinity of Beijing will be notified later by Chinese Ski Association.

5-4 Site for the 15th Asian Alpine Ski Championships 2006 (Junior)

India and Korea proposed to conduct the 15th Asian Alpine Ski Championships (Junior) in 2006. President is to evaluate the situation of India in respect to the condition of alpine courses, the stability of the area access to the venue. He needs to discuss the matter with the FIS Alpine Course Committee. If India is not accepted, Korea will undertake the 15th Asian Alpine Ski Championships 2006 (Junior).

6. Election

6-1 Election of Officials (New ASF Council Members for 2004-2006)

According to the ASF Statutes, the congress is to elect the council members for 2004-2006. Dr. Sung-Won LEE, Korea, was re-elected as President. Mr. Shoji MARUYAMA, Japan, was re-elected as vice president. Mr. Yitao WANG, new president of Chinese Ski Association of China was newly elected as vice president, succeeding Mr. Tian XIAO, former president of Chinese Ski Association.

The vice presidency from Iran is to be finalized later in connection with result of decision about abolishment of the Finance and Marketing Committee to be studied by the presidential group as explained in the item 4-3 "Report on the Activities of the Finance & Marketing Committee for 200-2002". In accordance with the mandate given to the president for the problem of the Finance & Marketing Committee and the related vice presidency linked with the chairmanship of the committee, the issue will be decided soon. Furthermore, the I. R. of Iran Ski Federation had conveyed their intention to ASF and FIS to elect Issa Saveh SHEMSHAKI, president of Iran Ski Federation as vice president of ASF.

Mr. Wei-Min PAN was elected director from China, replacing Baiqing SUN. Mr. Tim Ting-Fung LIN was elected as director from Chinese Taipei, replacing Thomas Ren-Guey LIANG, Mr. Zulfiqar Hussain KHAN was elected as director from Pakistan, replacing Mr. Javed HABIB. President welcomed the 3 newly elected directors. 7 other directors were re-elected and remain same. 2 auditors were re-elected and remain same. Mr. Takahashi SASAKi of Japan was elected as secretary liaison, replacing of Mr. Aki MURASATO.

Resolution: Unanimously approved.

6-2 Decision on Next 7th ASF Council Meeting in 2005

The congress unanimously approved to hold the 7th ASF Council Meeting during the 14th Asian Alpine Ski Champions (Children) in China. In view of the fact that it is rather difficult for council members to assemble together for council meeting between two congresses every time, we simply take the meeting of participating coaches or officials to the championships as a simplified delegated council meeting. Such a meeting will take up any subjects of mutual interests and have free conversations with a simple note if any. ASF secretariat would announce detailed informations later after Chinese Ski Association comes up with final schedule for the championships.

7. Any Other Business

There was no other business to take up and discuss. Therefore, the closing of the congress was announced.

Dear Sir.

Indian team participated in 13th Asian Junior Ski Championship at Dizin in I.R. Iran from 9th to 13th March 2004. They enjoyed participating in the championship. However, the team faced lot of difficulty in reimbursement of air fare and return journey.

No air fare has been reimbursed although it was promised in your instructions. This is unfair and unjustified.

Secondly our team had faced many difficulties such as follows:—

- There was no proper reception at Tehran. The team had to wait for a long time before your 1) representative met the team three hours after arrival.
- You had promised and extended invitation till 13th March 2004. But on 13th March 2004, Indian team 11) was denied your hospitality.
- Indian team had confirmed air tickets by Kuwait Airways before leaving India. However, your representative Intimated Indian team chef-de-mission Brigadier V.K. Chopra that Kuwait Aliways had cancelled the reservation. Thus Indian team of 4 persons was in great difficulty in a foreign country in returning to India. After lot of argument, Indian team was provided air tickets from Tehran to Delhi via Dubai but denied reimbursement of air fare from Delhi to Tehran and back to Delhi.

A copy of complaint by Brig. V.K. Chopra, chef-de-mission of Indian team is enclosed for your perusal.

We request you to look into the matter deeply and reimburse air fare of Indian team.

As Dr. Lee, President of ASF mentioned on the fax, ASF would be responsible for new ticket payment for return travel from Tehran to Delhi, after accounting the refund from previous round trip ticket. And we would like to request the invoice for new return ticket and refund of cancelled ticket. We will remit your bank account as soon as we receive your evidencing invoices.

We kindly ask you to send the solution letter for this trouble to the FIS also. Because you already sent the letter including complaint, we have to receive the continuous support from FIS for developing Asian ski sport.

We need to discuss about this trouble in details on the next ASF Congress 2004 in Miami. We would like to have your confirmation response immediately.
